Thankfully, the pandemic entered a different stage in 2022. But with violence on the rise, even more survivors need our community's support now and in the years ahead. When survivors speak out about their journeys - not just the pain but the bravery and support that helped them survive and thrive – that never fails to inspire me. In 2022, we developed compelling campaigns to spread the word about key issues including: gun and community violence campaigns, #TraumaTakesTime to discuss why we must believe survivors when they come forward on their own timeline, and how our staff and community have gone #BeyondTheCall to tap into determination and resourcefulness to show up for survivors. I hope you will feel inspired by the stories shared in this report and accompanying videos on our website.

Our Impact

We provide assistance, advocacy and support to people who have experienced domestic violence, child abuse, sexual assault, stalking, human trafficking, youth homelessness and other forms of violence. Our community is comprised of thousands of partners who are advocates, survivors, professionals, and donors who come together and support the 1 in 33 New Yorkers who find safety and hope through Safe Horizon each year.

The reach and impact of some of our programs during the period ended June 30, 2022 include:

Children Experiencing Extreme Physical or Sexual Abuse

Our five Child Advocacy Centers (CACs) which are co-located spaces with ACS, NYPD, DA, Medical Services, and are coordinated by Safe Horizon saw **8,869** children and **3,997** caregivers.

Sheltering Families Reclaiming their Lives

We welcomed **819** survivors of domestic violence and their **1,169** children who found safety and began their journeys to healing in one of our eight Domestic Violence Shelters.

Supporting Survivors

Our Crime Victim Assistance
Program (CVAP) connects Safe
Horizon advocates and survivors
of crime or domestic violence in
86 NYPD commands, and select
Special Victims Divisions. CVAP
advocates worked with a total of
35,329 survivors.

Community Programs

provide practical assistance, crisis intervention, supportive counseling, and case management for survivors of crime to **1,165** clients.

Legal Programs

Domestic Violence Law

Project (DVLP) provides free representation, information, and consultation to domestic violence victims – we served **1,117** clients.

Immigration Law Project (ILP) provides advice and low-cost legal representation to victims of crime with immigration law-related matters. We provided representation or advice to 903 clients, and 4,686 information and referral calls.

Anti-Trafficking Program (ATP) provides legal and social work services to survivors of labor trafficking and sex trafficking. We worked with 295 clients and provided 1,204 telephone counseling sessions.

Hotlines, Help Line and Safe Chat

Our three 24/7 Hotlines answered 102,825 calls. Our Hotlines include the Domestic Violence Hotline (87,969 calls), the Rape and Sexual Assault Hotline (9,138 calls), and the Crime Victims Hotline (5,718 calls). Advocates offer personalized, nonjudgmental advocacy, supportive counseling, and referrals.

The Helpline - our centralized telephone intake center serving all Community Program offices - connected with clients at **5,095** unique telephone numbers.

Safe Chat conducted **1,003** online chats where survivors ask questions and explore options.

Young People Experiencing Homelessness

The Streetwork program operates two drop-in centers, an overnight shelter, and an outreach program for homeless youth. Streetwork drop-in centers provide practical assistance (showers, hot meals, clothing), case management, and mental health services. We worked with **1,237** clients across the drop-in centers and the overnight shelter, and our outreach team had **10,716** contacts.

Responding to Community and Gun-related Violence

Gun violence has become more prevalent in New York City and across the country. [According to one CSC study in 2022 about 124 people die from a firearm-related injury each day.] Many New Yorkers may not fully understand the far-reaching impact that gun violence has for survivors and their families and communities. For communities of color and particularly boys and young men of color, many people don't know gun violence support is available or simply aren't offered help.

In 2022 Safe Horizon launched a digital campaign to raise awareness of this issue and of the resources Safe Horizon provides. Gun violence can happen to you or someone you care about. When these incidents occur, it is important not to blame the victims of a shooting for being in the way of a bullet.

When there is an incident involving a gun, there is an effect on an entire community, not just one person. In the aftermath of a shooting incident, the family members of the person who may have been shot are deeply affected. Community members who heard or witnessed the shooting are impacted by the trauma of being near a shooting incident, and an individual survivor has to cope with the traumatic aftermath of being shot or shot at. Some people may experience anxiety or fear about leaving their home or walking outside because of the trauma experienced during the shooting. Sadly, often families grieve the loss of a family member killed.

At Safe Horizon we are raising awareness of the factors that contribute to the rise in gun violence. These factors include economic factors, systemic racism, and the environments in which people live. We urgently call for common sense gun reforms, and for critically needed responses to the economic and mental health conditions that contribute to gun violence.

Advocating for Survivors of Sexual Assault

Too often when sexual assult survivors speak out about what they experienced, they hear questions like: Why did it take you so long?

At Safe Horizon, we never ask that question Instead, we say something far more important to survivors: I believe you! At Safe Horizon we know that #TraumaTakesTime. Readiness to come forward can take months, years, and even decades.

The Road to Justice for Survivors

Many survivors of sexual assault need time to process the hurt they've experienced. For years, New York State laws were out of step with that reality. Beginning around 2007, New Yorkers advocated for legislation that would expand the ability for survivors of childhood sexual abuse to have their day in court. Known as the Child Victims Act (CVA), this legislation created meaningful and long-overdue statute of limitation reform for adults who experienced sexual abuse before their 18th birthday. The Adult Survivors Act (ASA) created a one-year look back window for adult sexual assault survivors who are outside the statute of limitations.

Here is a snapshot of the milestones that brought us to these new reforms:

2006

Safe Horizon joins a coalition of survivors, victim service providers, advocacy organizations, and national experts to advocate for statute of limitation reform for survivors of childhood sexual abuse.

2019

After 13 years of being proposed in the New York State legislature, the CVA passes both houses and is signed into law. The CVA officially takes effect in August.

2019 Summer

Safe Horizon launches a public awareness campaign to inform New Yorkers about their new rights under the CVA.

2020 Winter

Members of the state legislature who sponsored the CVA introduce the ASA.

2020 Summer The CVA one-year lookback window is extended in light of the COVID-19 pandemic.

2022 Spring The ASA passes in both houses and is signed into law by Governor Kathy Hochul.

2022 Fall

Safe Horizon launches an awareness campaign, premiering a PSA in Times Square where survivors and lawmakers stood together in solidarity.

The 1-year window of the ASA officially opens on Thanksgiving, meaning any adult survivor – no matter when they were assaulted and even if they are outside the statute of limitations – can file a civil case against their abuser or the institution that protected them, through November 23, 2023.


