A Message from Our CEO



Thank you for making 2014 yet another year of remarkable achievement for Safe Horizon! This year, we led the way by empowering over a quarter of a million people affected by violence and abuse, helping them to move from crisis to confidence. This was only possible with help from our generous individual, corporate, foundation and government partners.

As the largest victim services organization in the country, we pride ourselves on our tireless advocacy for victims of violent crime.

After seven long years of advocacy on behalf of abused children, we signed a contract with New York City to open a Child Advocacy Center (CAC) in the Bronx. This CAC, Safe Horizon's fifth, will ensure that our hope and healing for child victims extends to all five boroughs of New York City.

This year, when a tragic explosion in East Harlem destroyed two buildings, killing eight people, New York City desperately needed help providing disaster relief. Safe Horizon had demonstrated our versatility as a social services organization in the aftermath of 9/11, and we gladly rose to the challenge when New York City's leadership again looked to us to provide case management, counseling, and funding distribution for victims.

Safe Horizon is recognized nationally and internationally as an innovator in victim services. Delegates, dignitaries and scholars from across the U.S. and countless other countries around the globe visit our programs every year to learn more about our services for victims, and this year was no exception. Notably, French Secretary of State Laurence Rossignol visited our Brooklyn Child Advocacy Center to discuss her desire to implement similar facilities for abused children in France.

We are also an influencer in mainstream and social media, where we seek both to promote and shape dialogue surrounding family and community violence. When news broke about domestic violence in the ranks of the National Football League, we were at the forefront of the discussion in national and local news outlets, and when the conversation turned to #WhyIStayed and #WhyILeft on social media, we were a prominent voice.

In 2014, Safe Horizon led the way for victims of violence – and, with your support, we will continue to lead the way in 2015 and beyond.

2014 Highlights

- Safe Horizon achieved a milestone in 2014 when we broke ground on our new Bronx Child Advocacy Center (CAC). With help from our partners at the New York City Mayor's Office of Criminal Justice, the New York City Police Department, the Administration for Children's Services, the Bronx District Attorney's Office, the New York City Law Department and Montefiore Medical Center, we will now provide hope, healing and justice for abused children living in the Bronx.
- Twenty best-selling mystery authors, including Mary Higgins Clark, Lee Child and Safe Horizon Board Member Linda Fairstein, collaborated to write *Inherit the Dead*, the proceeds of which benefited Safe Horizon. Safe Horizon celebrated the book's release with a party that raised more than \$166,000.
- Safe Horizon sponsored its first Domestic Violence Conference, "Real Safety: Embracing Client-Centered Practice with Domestic Violence Victims." The conference was a tremendous success, with over 200 service providers, partners and clients in attendance. The afternoon closed with a powerful talk by Tamron Hall, host of MSNBC's *NewsNation*, who shared the tragic story of how domestic violence took her sister's life.
- After an explosion in East Harlem destroyed two buildings and killed eight people, Safe Horizon was asked by the City to assist with disaster relief. We worked with the Mayor's Office to provide case management, counseling and distribution of victims assistance funding. We successfully supported nearly all impacted households.
- Our 19th Annual Champion Awards dinner in April was a phenomenal success, breaking all Safe Horizon records, with more than 1,000 guests in attendance and raising over \$1.5 million. The evening's host, Harold Ford, Jr.; presenters Linda Fairstein and Dr. Lisa Robinson; and honorees Tamron Hall, Steve Parrish and Jeff Brodsky all gave moving and inspirational remarks.
- Safe Horizon revitalized its engagement with rising leaders in 2014 by establishing a new group, Leaders on the Horizon, comprised of emerging leaders across various professions who support Safe Horizon's mission. Many members have already been active through Safe Horizon's new grassroots fundraising initiative, Team Horizon, which also launched in 2014.
- Safe Horizon's CEO Ariel Zwang was honored in 2014 with News Corp's Murdoch Community Hero Award, which is accompanied by a monetary allotment of \$600,000 for Safe Horizon over the course of four years.

Child Advocacy Centers

Safe Horizon has been a pioneer in changing the way child abuse cases are handled. Almost 20 years ago, we were the first organization in the country to bring everyone involved in child abuse response – pediatricians, child protective services, law enforcement, prosecutors and counselors – together under one roof, in a child-friendly facility called a **Child Advocacy Center (CAC)**. The goal of the CAC paradigm is to limit the further traumatization of already-victimized children in the most serious cases of abuse.

2014 marked an incredible achievement in Safe Horizon's struggle against child abuse: after years of advocacy on behalf of victimized children, we finally got the funding to open our

fifth CAC, ensuring Safe Horizon's hope, healing and justice for the children of all five boroughs of New York City. With the support of our partners at the New York City Mayor's Office of Criminal Justice, the New York City Police Department, the Administration for Children's Services, the Bronx District Attorney's Office, the New York City Law Department and Montefiore Medical Center, we proudly undertook this monumental project in the Bronx so that every victimized child in the five boroughs will have access to the best in child abuse intervention, investigation and treatment.

In 2014, Safe Horizon’s CACs were an important resource for **7,065** child victims of sexual and severe physical abuse and their families. These children benefited from Safe Horizon’s comprehensive, holistic approach to investigating cases, treating victims and pursuing perpetrators.

This year, we continued to work with the Yale Child Study Center to expand the implementation of our groundbreaking intervention for abused children and their families, the Child and Family Traumatic Stress Intervention, and we have led the way in recognizing and responding to cases of commercial sexual exploitation of children. We also continue to advocate for legislative changes that would give adult victims in New York State longer periods to hold their abusers accountable in court.

Hotlines and Domestic Violence Programs

That’s why I strive to instill a sense of hope through the services we provide, to engage them and help them to see that there are better things to come, and to create a warm, welcoming environment where healing can begin.”

Safe Horizon has four **Hotlines** for victims of crime: our Domestic Violence Hotline, our Sexual Assault Hotline, our Crime Victims Hotline and our Centralized Hotline. Multilingual support is available 24-hours a day. In 2014, our Hotlines answered **112,164** calls from victims of violent crime reaching out in their times of crisis. Our Domestic Violence Hotline is usually the point-of-entry for victims seeking shelter at one of our eight domestic violence shelters.

As the nation’s largest provider of domestic violence services, Safe Horizon’s eight **Domestic Violence Shelters** provide over

700 beds to women, children and families fleeing domestic violence, providing safety and refuge for **2,461** women, children and families in 2014. Safe Horizon offers six emergency and two transitional shelters for victims.

While staying in our shelters, families receive counseling to overcome the trauma of abuse and case management to facilitate their search for the resources that will help them to rebuild their lives. This includes assistance acquiring safe long-term housing and support finding jobs that allow them to establish economic independence. With increased help from our partners, we hope to

provide more efficient services to help homeless families move towards long-term financial literacy and economic independence.

In 2014, the Executive Director of UN Women, Phumzile Mlambo-Ngcuka, visited Lang House as part of the UN's campaign to end violence against women. While at the shelter, CEO Ariel Zwang and former Safe Horizon client Dr. Lisa Robinson joined Ms. Mlambo-Ngcuka in being filmed for a documentary.

As part of the NO MORE coalition, Safe Horizon was invited by Vice President Joe Biden and the Council of Women and Girls to a meeting at the

White House about ending domestic violence and sexual assault.

Safe Horizon offers free and low-cost legal representation to victims of domestic violence who are low-income or unable to access resources. Without these crucial services, such victims have difficulty obtaining the legal assistance they desperately need to break free of their abusers. During 2014, Safe Horizon helped **1,577** victims and families through our **Domestic Violence Law Project**, providing legal advocacy, information and referrals in cases involving child custody, orders of protection and more.

Criminal Justice Programs

"Often in the criminal justice system, people are reduced to numbers – they're nothing but a plaintiff or a defendant. But here, a victim of crime will be listened to in a non-judgmental, collaborative environment by a team of experts. Anyone who walks through our doors will be welcomed with courtesy, respect and compassion."

Safe Horizon's **Family and Criminal Court Programs** provide reception centers, complaint rooms and petition rooms in the Family Courts of Manhattan, Brooklyn, Queens, Staten Island and the Bronx and the Criminal Courts of Brooklyn, Queens, Staten Island and the Bronx. Additionally, we partner with other organizations to help crime victims at collaborative **Family Justice Centers (FJC)** in Manhattan, Brooklyn, Queens and the Bronx.

In 2014, our Family Court Programs helped **4,929** crime victims and provided a safe reception space to **18,774** victims and their families. In 2014, our Criminal Court Programs and FJCs helped **6,542** crime victims and provided a safe reception space to **16,981** victims and their families.

Our Court Programs provide comprehensive services for victims of violent crime, including

information about court processes, concrete services like food vouchers and transportation, and referrals to other Safe Horizon programs. We also offer safety assessments, safety planning and assistance in filling out Office of Victim Services compensation claims.

In conjunction with the New York City Police Department and the New York City Housing Authority, our **Domestic Violence Police Programs (DVPP)** make home visits, follow-up on reports of domestic violence, and hold awareness workshops for law enforcement and community groups throughout all five boroughs. In 2014, Safe Horizon's DVPP provided crisis intervention, counseling and advocacy to **8,117** domestic violence victims and conducted **16,864** outreach calls to victims of domestic violence incidents.

Children's Centers

Safe Horizon's six **Children's Centers**, located in courthouses throughout New York City, provide free, supportive, educational child care up through age 12 for victimized families so that they are able to seek justice.

Children can choose to work with the Children's Centers' teachers on their homework assignments or prepared age-appropriate lesson plans. A vast collection of toys and nutritious snacks are available.

In 2014, we supplied this crucial service for **11,398** children, supporting them and their families during their moments of crisis.



Streetwork Project

"I'm inspired by the long-term impact we have for so many of these young people. A lot of them have never felt loved, have never felt listened to – have never had healthy relationships with adults they can trust. At Streetwork, we offer them help without ever asking for anything in return. When the young people see the effort we put into them, when they see that we really care, that has the power to make a fundamental difference in their lives."

Safe Horizon's **Streetwork Project** provides essential services for homeless and street-involved teens and young people, including safe refuge from the dangerous streets, counseling, emergency shelter, showers, laundry facilities, STI testing, food and other practical assistance. In 2014, **1,009** homeless young people made **20,793** visits to Streetwork, receiving over **65,000** meals.



Anti-Trafficking Program and Immigration Law Project

Safe Horizon's **Anti-Trafficking Program (ATP)** is one of the largest service providers for victims and survivors of human trafficking in the United States. Through fully integrated social and legal services, including emergency intervention, advocacy, long-term legal representation, and practical resources, our ATP makes it possible for children and adults who have been illegally exploited by traffickers to escape from modern-day slavery and reclaim their lives. In 2014, Safe Horizon's anti-trafficking program helped **306** victims to escape the terrifying crimes of sex and labor trafficking.

ATP is a recognized leader in its field: in 2014, the Department of State's Office to Monitor and Combat Trafficking in Persons met with ATP to discuss trends in human trafficking and the best practices in assisting victims.

In 2014, ATP assisted three labor trafficking victims with high-profile cases: Felicitas del Carmen Villanueva Garnica, María Ríos Fun and Sangeeta Richard. All three victims were held against their will in terrible working conditions for far less than legal wages. Coverage in the press spanned major media including local, national and international outlets, and Safe Horizon was a prominent voice, shifting media focus from the traffickers' rationalizations to the plight of the victims.

"At ATP, we are able to provide comprehensive services within a single team. That allows us to use our direct service experience to lead the way as advocates and results in a level of credibility and expertise which few other organizations around the country can offer."

Safe Horizon's **Immigration Law Project** provides free and low-cost services to immigrant victims of crime, torture and abuse. In 2014, we offered legal representation, information and advice to **617** victimized immigrants and information and referrals over the phone to **3,150** additional members of this extremely vulnerable population.

Three notable cases in 2014 included a young Sri Lankan man who fled his home country after being sexually assaulted as part of a hate crime against him due to his sexual orientation; a person who was forced to flee killers after witnessing a murder by jumping out of a second-story window and hiding under a truck; and a Guatemalan woman who had been severely assaulted by her violent husband.



Community Programs

“This program is vitally important in the lives of crime victims. We take the time to understand our clients’ priorities – what they want and need. Our goal is to help them to make the decisions that are best for them. They walk away feeling that they’ve been heard because we help them begin to take ownership over their own lives.”

In the aftermath of violent crime, Safe Horizon’s **Community Programs** give critical support to victims. For survivors of domestic violence, rape and sexual assault, or the families of homicide victims, our Community Programs are a vital resource. In 2014, Safe Horizon’s Community Programs served **4,307** survivors of violence.

Our Community Programs’ broad offerings include emergency assistance, information and referrals,

short-term counseling, support groups and advocacy. Our Community Programs offer specialized support and services for victims and serve as an educational resource, raising awareness about how violence impacts victims and the community at large.

Safe Horizon’s **Project Safe** gave the gift of safety and security to **1,022** victims of violent crime in 2014 by providing free lock changes. Recipients can once again feel safe and secure in their own homes.

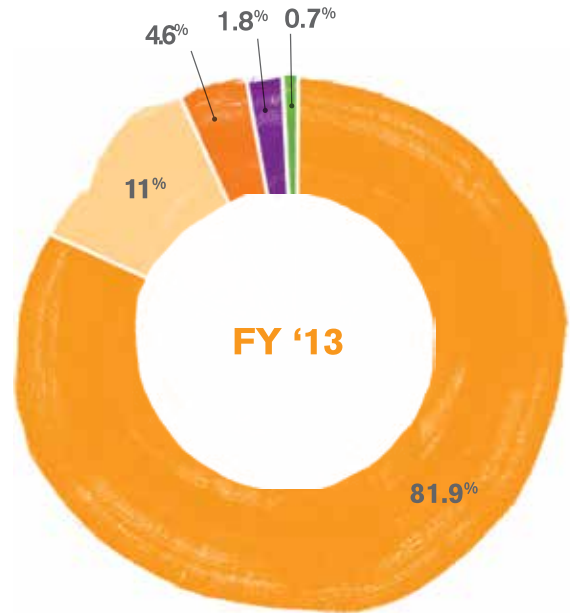
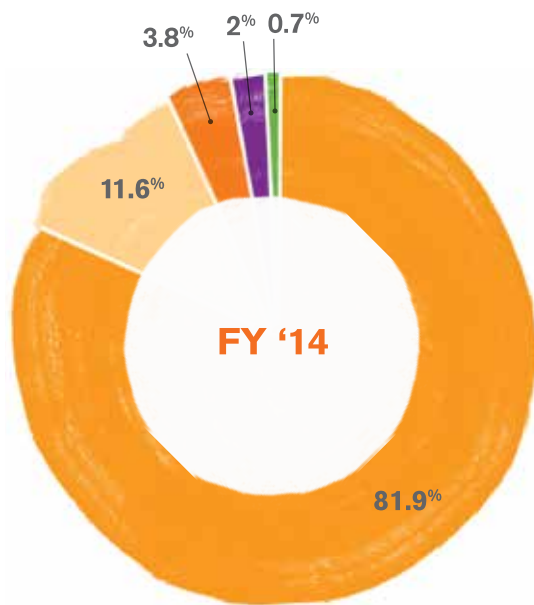
Safe Horizon's **Counseling Center** is New York State's only licensed mental health clinic that exclusively specializes in treating traumatized victims of crime and abuse, including child abuse victims, adult survivors of child abuse, domestic violence survivors, and the family members of homicide victims. Our Counseling Center treats survivors of all cultures and socioeconomic backgrounds, and has successfully treated victims of trauma aged seven months to 78 years.

All counselors are extensively trained in numerous research-proven treatment models and only use treatments that research has found to be successful. In 2014, our Counseling Center provided more than **7,000** hours of mental health treatment to **609** child and adult survivors of abuse and their families to set them on the path to recovery.
